

## *Greetings from the GTAP Hub!*

### Message from the Director

Dear GTAP Network Members,

As I complete my first year as Director, I want to begin by expressing my sincere appreciation for the warm welcome and the tremendous support I have received since assuming the role on January 1. It has been an energizing and deeply rewarding year. For this first year, I have sought to reach out to network members as much as possible to better understand your priorities, learn from your experiences, and gain a richer sense of the global network that makes GTAP what it is. In this context, I made a special effort to visit every GTAP Consortium member institution—meeting as many as possible in person. These conversations have underlined GTAP’s strengths and provided motivation for goal setting for the future.

#### **2025: Important Landmarks**

Although many developments could be highlighted, I will focus here on three that stand out.

##### **1. Annual Conference in Kigali**

The [28<sup>th</sup> Annual Conference on Global Economic Analysis](#)—held in Kigali in June in collaboration with UNECA—was a tremendous success. It brought together participants from around the world and featured a memorable keynote address by Dr. Akinwumi Adesina, President of the African Development Bank, who offered a compelling vision of Africa’s role in the global economy. I am grateful to all who contributed to planning and execution. The Kigali conference strengthened GTAP’s role as a global convening platform and reinforced the importance of our community in addressing today’s most pressing policy challenges.

##### **2. GTAP 12 Data Base**

At the GTAP Advisory Board Meeting in June, we agreed to prioritize a version of the database capable of analyzing the dramatic changes unfolding in the world trading system. Thanks to the extraordinary efforts of the GTAP data team and numerous collaborators,

GTAP 12 was made available to consortium members in October. For the first time, the release includes two new reference years—2019 and 2023—providing a rich basis for evaluating the evolving trade landscape. The public release of GTAP 12 is expected in January and I extend my congratulations and gratitude to everyone involved in this significant achievement.

### **3. Circulation of [“A Vision for GTAP to 2035 and Beyond”](#)**

This year also marked the circulation and discussion of a vision document setting out a forward-looking strategy for GTAP’s evolution. The document outlines a modern analytical landscape rooted in modular, integrated approaches; a transformation in how we build and deliver data services; a comprehensive, high-quality training program; and a stronger platform for policy engagement. It aims to guide our collective efforts through 2035 and beyond, ensuring that GTAP continues to deliver public goods that are globally relevant, analytically rigorous, and impactful.

## **Priorities for 2026**

Coming year priorities align closely with “Vision to 2035” framework. Three areas are highlighted.

### **1. Research Priorities for the GTAP Hub**

Researchers associated with the GTAP Hub will continue to pursue their own research agendas based on their interests and expertise. At the institutional level, however, GTAP will place added emphasis on three research domains that offer broad benefits to the network:

**Scenarios and foresight** - As global uncertainties multiply—including in trade, finance, technology, food systems, natural capital, and climate—GTAP will enhance capabilities for generating and analyzing forward-looking scenarios. The aim is to make available well-founded scenarios across the network.

**Model validation and parameterization** - High-quality policy analysis depends critically on sound parameterization and validation. GTAP will seek to elevate this work, prioritizing transparent procedures, comparison across alternative datasets, and new empirical strategies to strengthen confidence in analytical results.

**Model inter-linkages** - GTAP can play a unique role in facilitating linkages across modeling frameworks. As the vision document notes, modular approaches—what we call an Integrated Assessment Network—are increasingly deployed for addressing complex global problems. GTAP will invest in the methodological and organizational infrastructure needed to support these linkages.

### **2. Comprehensive Course**

Building on more than three decades of experience in teaching economywide modeling, GTAP is laying the groundwork for a comprehensive online course series, as described in the vision document. The goals are ambitious: to expand the global supply of highly skilled economywide modelers, strengthen analytical capacity across institutions, and support countries in building robust economywide modeling ecosystems. The course will be modular, rigorous, and aimed at meeting the growing demand for training at multiple levels—from savvy users of research to full GTAP-certified modelers. This is a major investment in the future of our field and a core element of GTAP’s mission going forward.

### **3. Country Communities**

Finally, GTAP will continue to expand engagement with key emerging economies. While the GTAP Advisory Board already benefits from strong participation by international organizations and institutions in high-income countries, representation from large emerging

economies remains relatively weak—despite the centrality of these countries to global economic and environmental outcomes. GTAP is working to deepen collaboration and build modeling capacity in emerging economies with ongoing activity in Brazil, South Africa, India, Indonesia, and Vietnam. These initiatives build directly on the country communities concept articulated in the vision document.

### **A Word of Thanks**

From all of us at GTAP, thank you for your continued engagement, support, and partnership. The strength of GTAP lies in the diversity, creativity, and collegiality of its network. As we look toward 2026, we remain deeply committed to GTAP's core philosophy of collaboration in areas of mutual benefit, capacity building, and an open marketplace for ideas—and equally committed to innovation and ambition as we confront the challenges and opportunities ahead.

We look forward to working with you in the coming year.
