The GTAP model simulation studies have been utilized to analyze the impacts of several structural policy measures like trade and investment liberalization, climate change and economic development.

During the last year, the progress of bilateral and multi-lateral Economic Partnership Agreements (EPAs) has accelerated, which has included the Trans-Pacific Partnership (TPP), a China-Japan-Korea (CJK) EPA and Regional Comprehensive Economic Partnership (RCEP) toward the establishment of a Free Trade Area of the Asia-Pacific (FTAAP) as well as a Japan-EU EPA and a Transatlantic Trade and Investment Partnership (TTIP). Researches into them at RIETI have made major contribution to studying the economic impacts of those EPAs in particular in policy arena.

1. The TPP

The Japanese Prime Minister Abe expressed his intension to participate in the negotiations on the TPP at the press conference in mid-March this year. It was followed by the press release of the Government's estimates on the economic impacts of TPP participation on the Japanese economy. Until that time, earlier studies shown in Kawasaki (2011)* had been widely reported by media and frequently been cited in political debates including those at the Diet as the GTAP analysis.
