CEPII's team has been working in 2013-14 on the update (2007) of the FDI database for GTAP, as well as long term projections based on the MIRAGE-e model and a variety of simulations, including assessment of the Transatlantic Partnership and of a carbon tax policy. The scientific article documenting the construction of the macro-economic baseline for MIRAGE has been published; the code and data have been posted on the website of the Center. The team has finally been involved in the computation of tariff equivalents of regulatory obstacles. Below is an indicative list of CEPII's GTAP-related publications.
