CEPII's team has been working in 2014 on the update of the baseline of the MIRAGE model, better integration of non-tariff measures in MIRAGE, along with compatibility to GTAP 8.2 database. A new database has also been released containing indicators measuring the incidence of NTM. In addition, the MIRAGE model has been used for a variety of simulations, including assessment of the Transatlantic Trade and Investment Partnership.
