January 2006	Begin work on GTAP 7
	 data requests; build plumbing
Spring 2006	GTAP 7 pre-release 1 – new/updated I-O tables; international datasets for 2003
Rest of 2006	2 or 3 more pre-releases of GTAP 7, as needed
April (July) 2007	GTAP 7 release to GTAP board (public)

 - Others from Africa and Latin America?

(public)	(Nov `03)	Various bug fixes

- Added new and updated tables only
- No changes to international datasets
- Minor changes to international data in 5.4 for bug fixes

Interim Release Questions?

- Add I-O tables only as in GTAP 5? Users work with same database but can use data on new/updated regions.
- If 2001 IEA energy price data will make a significant difference, should we include it in an interim release?
- Bilateral detail in services trade has been promised for sometime. We're getting closer, should we do it now or wait for GTAP 7?
- Other data issues, e.g. sugar classification, textiles/clothing mapping? Are these important enough to warrant inclusion in an interim release?
- What if other critical issues related to international datasets emerge?

Rest of 2006 April 2007	2 or 3 more pre-releases of GTAP 7, as needed GTAP 7 release to GTAP board
