Summary of GTAP-related activities

2006 - May 2007

Below is a list of CEPII's GTAP-related publications.

Among noteworthy activities is also the fact that the CEPII is animating a Group of Scientific Interest (GIS) focused on Trade policy, created in 2002, jointly with the INRA (French institute for agronomic research) and the French Ministry of Finance (Treasury and Economic Policy Directorate). This Group facilitates exchanges and co-operation between its members, and organises seminars on trade policies.

The CEPII has in addition provided the pre-release of MacMapv2, based on 2004 tariffs. Updated documentation for this database is made available at <http://www.cepii.fr/anglaisgraph/bdd/macmap.htm>.

The CEPII has developed a FDI database compatible with the GTAP database. A pre-release version will be made available for comments.

The CEPII has participated in the development of the trdmat (preliminary name) utility built by Mark Horridge. It will allow a more friendly use of MacMapHS6 for the GTAP community (aggregation, compatibility with GTAPAGG, Splitcomm and special features for implementing tariff reductions).
