## **Projects:**

  - Develop a SAS based tool for a flexible calculation of WTO tariff cuts in the tariff data base at the 6-digit HS level.
  - Analyze the impacts of different tariff aggregation methods (import weighting, TRI, MTRI) and include these options in the SAS tool.
- 2. DFG (German Research Community; Deutsche Forschungsgemeinschaft) Research Group project: Effects of the WTO Negotiation on Global, National and Farm Level. Main activities:
  - Extensions of the GTAP to improve the modeling of domestic support, particularly AMS.

  - Development of a consistent interface between GTAP and FARMIS including a further disaggregation of the GTAP data base.

  - Disaggregation of commodity markets employed in bioenergy sector and corresponding adaptation of the GTAP model
