GTAP Data Cycle

- Pre-releases (as we bring in data inputs)
 - Switch to new base year
 - New and updated I-O tables
 - Updated international datasets
 - Any new data (e.g. taxes, parameters)
 - Released only to consortium member agencies and data contributors
- Final (public) release
- Interim Releases
 - Any new or updated I-O tables
- Special Data Projects

Recent Data Releases

- Africa Data Base (Stage 1) Mar 2007
 - Built on GTAP 6.2 Data Base
 - I-O data for new regions based on existing data
- GTAP 7 pre-release 1 April 2007
 - 2004 reference year, 101 regions and 57 sectors
 - Macroeconomic aggregates, merchandise trade, protection data
- GTAP 7 pre-release 2 May 2007

Improved bilateral services trade data

Africa Data Base

- Special Project funded by the European Commission and the World Bank
- Built on GTAP 6.2 Data Base (2001 ref. year)
- Africa is split into 31 regions (up from 19)
- Stage 1: new single regions based on other African I-O data in the GTAP 6.2 Data Base
- Data packaged as 40 regions x 57 sectors
- Meeting for Africa Project: tomorrow, 5:30-6:15pm

GTAP 7 Pre-releases 1 and 2

- 2004 reference year, 101 regions, 57 sectors
- 3 new regions (Nicaragua, Kazakhstan, Kyrgyzstan)
- 4 updated I-O tables (CHN, IDN, CHL, TUR)
- 3 corrected I-O tables (BEL, LUX, FRA)
- 2004 macroeconomic aggregates
- 2004 merchandise trade
- 2004 domestic support for OECD and disaggregated EU
- agricultural export subsidies (2004 or most recent)
- 2004 preferential tariffs
- 2003\2004 ATC ETEs
- All the above plus
- improved bilateral services trade data in pre-release 2

Release Practices

- Pre-releases
 - Board members (and data contributors) are notified of the availability of pre-release on the website
 - Bugs are addressed in next pre-release
- Final release and interim releases
 - Board members (and data contributors) are notified of the availability of release candidate on the website
 - Release candidate becomes interim release after one month if no substantial feedback; else construct new release candidate
- Previous releases maintained on GTAP website for board member access
- Release notes for pre- and interim releases; Full documentation for final release
