## Centre d'études prospectives et d'informations internationales (CEPII, Paris) Summary of GTAP-related activities 2010 - May 2011

CEPII has been working in 2010-11 on the update of MAcMapHS6 for GTAP, based on tariff information at the detailed level from MAcMap (ITC, WTO-UNCTAD). An updated version of the FDI database for the year 2004 (Gouel C., Guimbard H. and Laborde D.) has also been provided to GTAP, including new raw data and dealing with negative values for flows (the documentation is under review and will be released this year as a CEPII working paper).
