GTAP related work at FOI, 2010/11

African FTAs

FOI has and is working actively with tralac (Trade Law Centre for Southern Africa), modelling regional FTA between South Africa and a number of countries using the GTAP database. This work has resulted in the publication of a book forth coming in 2011 "CAPE to CAIRO: An Assessment of the Tripartite Trade Area" and a number of tralac working. Further work is on going with tralac.

China

The GTAP database has been use to model changes in agricultural domestic support in China. A journal article was published last year in the Journal of Agricultural Economics. Further work is ongoing modelling China's policy response to world market price changes. A paper will be presented at this year's conference.

Domestic support

FOI is contributing agricultural domestic support data for the EU which is has been incorporated into the GTAP version 8 database.

Decoupling of the SPS

Work is ongoing together with university of Hohenheim on Decoupling of the Common Agricultural Policies (CAP) Sing Payments Scheme (SPS) in the GTAP database. A paper will be present at this year's conference.

Work for the Danish ministry

Work has been undertaken modelling the consequences of a re-distribution of the CAP's SPS between the EU 27 member countries. This work will hopefully be published at a later data in a journal.

OECD paper

FOI has also contributed with model simulation to a paper commissioned by the OECD focusing on agricultural trade and employment in Southern Africa.
